(From the months of July - September 2010)

- At the July 14th Regular Meeting, Mr. Morgan motioned to hire two new part-time police officers on an as needed basis. - Motion Carried, All in Favor.
- At the July 14th Regular Meeting, Mr. Morgan motioned to replace Entech Engineering with Alfred Benesch through the remainder of 2010. - Motion Carried, All in Favor.
- At the July 14th Regular Meeting, Mr. Gotshall motioned to establish a Shade Tree Commission. After a very lengthy debate with council members the motion was tabled until more data is secured.
- At the July 14th Regular Meeting, Mr. Gotshall motioned to renew and amend a 5 year agreement to continue membership with Upper Schuylkill Revitalization. - Motion Carried, All in Favor.
- At the July 28th Special Meeting, Mr. Harper motioned to appoint Portnoff Legal Services to collect all delinquent garbage and real estate accounts and taxes for a 2 year contract. - Motion Carried, All in Favor.
- At the August 11th Regular Meeting, Mr. O'Boyle motioned to accept the contract for On Demand Energy with a 10%-18% savings. Motion Carried, All in Favor.
