RENTAL POLICY FOR PARTIES

I understand and agree that:

All persons that rent and/or attend the event are required to abide by all Frackville Community Pool Rules and Regulations. *A copy of current "Frackville Community Pool Rules" available upon request.

All persons given permission to use the property assume all responsibilities regarding injury and/or liabilities. *See attached Hold Harmless Agreement.

Contract Holder agrees to be responsible for any damages done to the property while this contract is in effect.

The contract holder agrees to clean up any/all debris after the scheduled event. Cleanup must be completed within one hour following the event.

Responsible adult supervision must be maintained at all times during use of the property

No drugs, alcoholic beverages, smoking, tobacco, vaping, or weapons are permitted in the Frackville Community Pool area or entire Memorial Park Complex.

The Borough is not responsible for lost or stolen articles.

Animals, except service animals, are not permitted in the Frackville Community Pool area.

Staples, nails, and thumbtacks are not permitted in the Frackville Community Pool area. Painter's tape ONLY permitted on any painted surfaces.

Inclement weather may require rescheduling of parties. Please contact Borough Office to reschedule.

CANCELLATION

The Borough of Frackville retains the right to terminate this agreement at any time or date deemed necessary or desirable. If the user cancels a reservation at least two weeks prior to the scheduled event, they are entitled to a full refund of all fees paid. If the user cancels a reservation less than two weeks prior to the scheduled event, the user shall not be granted a refund of any fees paid. If the Borough has an available date to reschedule the event, all fees paid will be applied to the future event.

It is hereby understood and agreed that the Borough of Frackville will make available for recreational use the Frackville Community Pool area and that I/we, the undersigned acting on behalf of all participants both individually and collectively hold harmless the Borough of Frackville, its officials, agents, employees, and volunteers from and against all claims for injuries to our participants or invited spectators resulting from our/their use of these facilities.

It is understood that I/we accept this condition in return for the use of the Frackville Community Pool and property on the date and time made available by the Borough of Frackville.

All participants should be notified the Borough of Frackville's liability for injuries is limited and defined under the Political Division Tort Claim Act (330-1978). We agree to notify the parents or guardians of all minors that they, and not the Borough of Frackville, will be responsible for expenses for medical treatment resulting from participation in any event for which we have requested this authorization.

The undersigned hereby acknowledges receipt of copies of all current Frackville Community Pool and premises rules and regulations concerning use of its facility and agrees to notify all participants in the event of the same and ensure that all participants and invited spectators abide by such rules and regulations. Failure to do so shall constitute grounds for termination of the contract without refund.
